All prospective bidders shall comply with all requirements to contract with the Government of Puerto Rico, in compliance with all latest applicable decrees, orders, legal decisions, and resolutions. Performance of all construction works needed to complete proposed repairs, improvements, are of civil/architectural facilities, mechanical systems (plumbing and air conditioning), and electrical systems (electric power supply & distribution, illumination, and voice/data communications). All professional design services and construction works shall be provided and performed in accordance with Contract Documents submitted as part of this RFP, and all updated applicable federal, state, and local construction standards, codes, laws, and regulations
